• Call to Order

Meeting was called to order at 1PM by Chair, Tom MacIntyre.

• Capacity Building Training: Counterproductive Strategies ("What Not to Do")

Joe Neigel presented an overview of counterproductive prevention strategies and activities. These are prevention strategies often rooted in good intentions or tradition, but have been shown by research to be ineffective or even counterproductive – unintentionally promoting harm instead of health. Strategies covered included:

- Scare tactics and scary images
- Exposing youth to testimony from former addicts
- Reinforcing incorrect or exaggerated social norms
- Distributing drug fact sheets
- Myth-busting presentation formats
- Focusing on drug benefits and dangers
- Roleplay instead behavioral rehearsal
- One time assemblies and motivational speakers
- Moralistic appeals
- Grouping at-risk youth together

MCC reviewed the Youth Coalition Subcommittee's "You are not alone" campaign video and discussed ways to support their efforts to reduce the risk factor, "Friends who engage in the problem behavior" by connecting atrisk peers to helping adults.

• E-cigarette Presentation

The Coalition heard a presentation providing background information about e-cigarettes, rapid teen adoption of this new substance abuse technology, and policy considerations being advanced by the Snohomish County Board of Public Health, the University of Washington and other prevention groups around the state concerned about the growing and unregulated vape industry.

- This educational presentation is a component of the Coalition's environmental strategy to educate and advocate for policies that reduce the availability of e-cigarettes to youth.
